These are just some of the accomplishments YOU helped us achieve in 2019!




Over **10,000** messages sent to provincial decision makers via our NEW digital campaign tools.



Exposed non-compliant logging of some of Earth's grandest forests and near-record-sized-trees in the Nahmint Valley in Hupacasath and Tseshaht territories.



Climbed, measured, & documented two giant Sitka spruce trees in Mossome Grove near Port Renfrew in Pacheedaht territory that were then later protected.




Prepared formal feedback submissions & mobilized supporters to provide input on Budget 2020, proposed changes to the Forest and Range Practices Act, and the BC government's Old Growth Strategy.



Explored and documented unprotected old-growth forests on Vancouver Island:

- Caycuse River Watershed - Ditidaht territory
- Central Walbran Valley, San Juan Valley & Edinburgh Mountain - Pacheedaht territory
- McKelvie Valley - Mowachaht/Muchalaht territory.



Launched our first "community spotlight" video focusing on Tahsis to help elevate the voices of communities on the "front lines" of ancient forest protection.



# Exposing Non-Compliant Logging by BC Timber Sales in the Nahmint Valley

In September, we received the results from a 2018 Ministry of Forests investigation into the logging of some of Canada's finest old-growth forests and monumental, centuries-old trees in the Nahmint Valley, located in Hupacasath and Tseshaht territories near Port Alberni.

The Ministry's report, obtained through a Freedom of Information request, showed BC Timber Sales, the BC government's own logging agency, failed to comply with the Vancouver Island Land Use Plan when laying out cutblocks in the Nahmint and hasn't protected enough old-growth forest to prevent biodiversity loss.

## 'Indicative of a truly corrupt system': government investigation reveals BC Timber Sales violating old-growth logging rules


Two investigations, released under Freedom of Information laws, show a government agency ignored best practices and available data when auctioning cutblocks in the Nahmint Valley — home to some of Vancouver Island's last remaining stands of unlogged ancient forest — where clearcutting continues to this day




Despite these findings, not only has the BC government allowed logging to continue in the Nahmint Valley, another 600 hectares of old-growth forest is slated for logging in coming years under the current, non-compliant forest stewardship plan.



# Keeping the Beauty and Destruction of BC's Ancient Forests in the Spotlight



In 2019, the AFA explored remaining unprotected old-growth forests in the Central Walbran Valley, Caycuse River Valley, the San Juan Valley, Edinburgh Mountain, and more, where we located spectacular ancient forest stands, monumental trees, and witnessed the devastating impacts of clearcut logging.

This monumental redcedar is located in the Central Walbran Valley, in Pacheedaht territory. It's now safe from logging thanks to the BC government's promise to protect 54 of BC's biggest trees, but there are countless other ancient giants and entire old-growth ecosystems still at risk across the province.

In May, we travelled to Tahsis in Mowachaht/Muchalaht territory to explore the beautiful McKelvie Valley, one of the last intact watersheds left on Vancouver Island, and to hear local residents' concerns about Western Forest Products' plans to log the valley.

We later launched our very first "community spotlight" video to raise awareness of the area and to highlight an innovative conservation proposal, "Salmon Parks," being championed by local Nuu-chah-nulth First Nations that could keep this magnificent valley intact.

# Expanding the Ancient Forest Movement



# Government Engagement & Lobbying



Through meetings with Ministers and bureaucrats, formal feedback submissions, and by flooding the inboxes of key decision makers with emails (thanks to you!), we continued to ramp up pressure on the BC government to implement both immediate and long-term measures to protect old-growth forests while supporting sustainable, second-growth forestry jobs and upholding First Nations' rights and title.



## BC Greens

**May 2019:** We joined the BC Greens at a press conference in Victoria where they formally called on the BC NDP to halt logging in Vancouver Island's last intact, low elevation old-growth forests.



## Budget 2020

**June 2019:** We spearheaded a joint submission to the Province, signed by 16 other conservation and recreation groups, calling for the creation of a provincial Land Acquisition Fund in the 2020 budget to purchase and protect endangered ecosystems on private lands, including old-growth forests.

## FRPA Amendments

**July 2019:** We mobilized thousands of British Columbians to submit comments on spring 2020 amendments to the Forest and Range Practices Act (the main piece of legislation governing forest practices in BC).

## Old Growth Strategy

**December 2019:** We launched an online call to action to encourage British Columbians to submit their feedback on the BC government's proposed Old Growth Strategy, demanding science-based legislation and policy changes to protect old-growth forests.

We adopted a new digital campaign tool that makes it even easier for British Columbians contact provincial decision makers. In 2019 alone, over 10,000 messages were sent - a true testament to the overwhelming support for increased old-growth forest protection in BC.




In April, 6,000 messages were sent to the BC government, opposing the auction of old-growth forests next to Juan de Fuca Provincial Park in Pacheedaht territory by BC Timber Sales. The mass mobilization of concerned citizens helped to temporarily stall the auction.

# Measuring Mossome Grove's Ancient Giants

With the help of our arborist friends at Expedition Old Growth, we climbed and measured two of Mossome Grove's tallest Sitka spruce trees, located in Pacheedaht territory near Port Renfrew, and submitted them to the BC Big Tree Registry. The biggest tree was measured at over 10ft wide at the base and came in at 246.5ft (75m) tall – as tall as a 23 story building!

These ancient giants are now safe from logging due to the BC government's promise to protect 54 of the biggest trees on the Big Tree Registry with one-hectare forested buffer zones, however, while there are no current logging plans for Mossome Grove, without sufficient policies and legislated protection, the future of endangered ancient forests like the unique and photogenic Mossome Grove remain uncertain.



### Funding Sources 2019



Our top priorities for 2020 include:




Supporting an academic study on the economic value of recreation in old-growth forests on Vancouver Island



Commissioning a GIS specialist to undertake mapping of old-growth forests in key areas on Vancouver Island



Further expanding our engagement with 'non-traditional allies' including First Nations, chambers of commerce, and tourism associations



Continuing to explore and document the beauty and destruction of BC's ancient temperate rainforests and engaging the news media to raise awareness



Mobilizing our supporters to increase pressure on the BC government to enact science-based protection measures for old-growth forests



Lobbying the BC NDP to support new and existing Indigenous Protected and Conserved Areas as well as funding for First Nations' conservation financing solutions

**With the BC government having promised to develop a new provincial Old Growth Strategy, 2020 is shaping up to be a pivotal year for the ancient forest campaign.**

**With your help, we'll work hard to ensure the Province's Old Growth Strategy is ambitious, science-based, and has a clear timeline for implementation.**
